VENDOR INFORMATION AND PARTICIPATION REGULATIONS

On **Saturday, September 6, 2025**, Cars and Stripes Classic Car Show (Cars and Stripes) day, **check-in starts at 10 am** at the Leroy Jackson Park parking lot, Ridgecrest, CA. **All Food Vendors must have their booths ready for inspection by the Health Department.** Cars and Stripes staff will do all non-Food Vendors inspections by 2:30 pm. The show opens to the public at 3 pm.

Pick-ups and cars only will be allowed on the car show grounds from 10 am - 2 pm. No commercial trucks will be allowed. **Re-stocking Booths:** Vendors may hand-truck additional items throughout the day, but cars and commercial vehicles will be prohibited from driving on the car show grounds between 3 pm **and 7 pm** on Saturday, September 6th. Food vendors will be organized according to the needs of the Health Department and to have better access to the entrance from the parking area. This will allow more accessible transportation of food for vendors throughout the day.

Car Show hours: Saturday, September 6, 2025, from **3pm-7pm**. All vendors are required to keep their booths open until the car show closes. Vehicles will be allowed onto the car show grounds once patrons leave, and the grounds are considered safe for vehicles.

1. No obscene or inappropriate items may be displayed or sold. The Cars and Stripes organizing committee reserves the right to terminate the sale of any product it deems inappropriate. Items referring to or promoting alcohol abuse, drug use, or violence, those that are racially offensive (such as racially charged paraphernalia), political in nature, sexually explicit, and suggestive in nature, are prohibited.
2. No items that are political in nature may be sold. Merchandise referring to political elections and political candidates is allowed. Cars and Stripes reserves the right to terminate the sale of any such product it deems inappropriate. The committee will require vendors to remove such items if displayed.
3. Basic space rental does not include electricity, canopies, tables, chairs, or linens unless otherwise noted on the completed contract.
4. Any heating equipment must be provided by the vendor per the health and safety regulations established by Kern County.
5. Providing tables and chairs is the responsibility of the vendor.
6. All booth tables must be covered. Linens cannot be rented through Cars and Stripes.
7. Participants provide any signage for all sales items, prices, etc. No handwritten or hand-painted signs will be allowed other than chalkboard signs.
8. Participants may hand out material about their organization only within the confines of their booth space.
9. All back-stock of supplies and products should be stored out of sight in the booth space.
10. Participants are solely responsible for merchandise, exhibits, and other equipment. Participants agree to hold harmless and indemnify the Cars and Stripes sponsors, the City of Ridgecrest, the County of Kern, Ridgecrest Area Convention and Visitors Bureau and its contractors, associates, and Cars and Stripes volunteers against all liability, loss, damages, claims expenses (including attorney fees) arising out of any injury to persons in or around participant booths/ areas.
11. Participants are solely responsible for product liability and accurate representation of any products offered for sale.
12. Participants are responsible for the disposal/removal of trash after Cars and Stripes, including all boxes, packaging, and recyclables.
13. Participants may not sublet their area. If sharing a space, the application must include sharing participant information.
14. **Cancellation:** Full payment of rental fees is required with an application. All fees are non-refundable.
15. If weather, major disaster, or other circumstances beyond the control of the sponsors/organizers cause the cancellation of Cars and Stripes, the participant waives any claims except for the return of rental fees.
